(सूचना)

सक्षम प्राधिकाऱ्याने जागा वाटप झाल्यानंतरची उमेदवार प्रवेशासाठी संस्थेत हजर झाल्यास संबंधित संस्थेने अवलंबविण्याची कार्यपद्धती खालील प्रमाणे नमूद केली आहे.

[The candidates who have allotted seats in CAP Round and who have accepted seats through their Login shall report to the institute as per schedule.]
