- 1. ज्या उमेदवारांचे कॅप राउंड 3 मध्ये जागा वाटप झाले आहे व ज्यांनी स्वता च्या login मधून जागेची निश्चिती (Seat Acceptance) केली आहे असे उमेदवार प्रवेशासाठी वाटप झालेल्या संस्थेमध्ये वेळापत्रकानुसार हजर राहतील.[The candidates who have allotted seats in CAP Round III and who have accepted seats through their Login shall report to the institute as per schedule.]
- 2. संस्था, जागा वाटप झालेल्या प्रत्येक विद्यार्थ्याची पात्रता निकष (Eligibility) व आवश्यक कागदपत्रांची काळजीपूर्वक पडताळणी करेल व उमेदवाराचा प्रवेश ऑनलाईन प्रणालीत संस्थेच्या लॉगइन मधून ताबडतोब अपलोड करेल व उमेदवारास प्रवेशाच्या पुष्टीसाठी पोर्टल च्या ऑनलाईन प्रणालीतून मिळणारी पावती व शुल्क भरल्याची पावती देईल.
