- 1. ज्या उमेदवारांचे कॅप राउंड IV मध्ये जागा वाटप झाले आहे व ज्यांनी स्वता च्या login मधून जागेची निश्चिती (Seat Acceptance) केली आहे असे उमेदवार प्रवेशासाठी वाटप झालेल्या संस्थेमध्ये वेळापत्रकानुसार हजर राहतील.[The candidates who have allotted seats in CAP Round IV and who have accepted seats through their Login shall report to the institute as per schedule.]
